


- 1. That Sar-La Education Trust is a Public Charitable Trust registered under the Indian Trusts Act, 1882.
- 2. That Sar-La Education Trust is a Public Charitable Trust and of Non-Proprietary Character.
- 3. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any shape whatsoever.
- 4. That no part of income from the institution is being and will be diverted to any individual in the Trust/School Management committee or to any other person/entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributes to developmental, depreciation and contingency funds will be further utilized for promoting the school and extending the cause of education in the same school only.
- 5. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.
- 6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any matter without obtaining affiliation.
- 7. That the Principal and Correspondent/ Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of land.
- 8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labor Laws etc. with respect to the school and staff of the school.
- That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time per the prescribed term.
- 10. That the school will ensure that all required infrastructure is available with the school
- 3HA11. That the school will ensure that a sufficient number of qualified teachers as per the rashtra India provisions contained in affiliation bye-laws are available with the school before starting agn. No. classes.
- Term Expires That the school will follow the provision related to fee contained in affiliation bye-laws 08/01/2025 and will disclose the details of the fee to the students/parents every year before start of session without restoring to any hidden charges in the head of the fee.
 - 13. That the school will not coerce any student/parent to buy books/stationary/uniform from any particular shop.
 - 14. That the school shall strive to make efforts for conservation of environment.
 - 15. That the school will ensure that the school fulfills all essential requirements before applying for affiliation and will fulfill all other conditions post affiliation and comply with all general rules as given in the affiliation bye laws or notified from time to time.
 - 16. That the school will not start CBSE pattern classes without submitting a commencement to the effect that the school has complied with all the condition imposed by CBSE and the post-affiliation conditions contained in affiliation byelaws along with general rules
 - 17. That IGCSE Board classes IX to XII and State Board Classes XI and XII running prior to the affiliation to CBSE would be sponsored for the State Board Examination and Cambridge examinations. The Classes IX to XII will be closed in a phased manner. No admission will be taken in the IGCSE and State Board classes after getting affiliation from CBSE. The IGCSE and State Board will be discontinued after switchover to CBSE.


